Your application and deposit MUST BE RECEIVED BY US NO LATER THAN AUGUST 22, 2018 If we are not in receipt of your application and deposit by the above date, your spot will be forfeited and we will contact the next person on the waiting list to fill this spot.

Your payment for the upcoming month is due by the first day of that month. Example: Your November payment is due by November 1st. Your account will be charged on the 1st of every month until you give 30 days email/written notice to cancel enrollment.

FINANCIAL ASSISTANCE IS AVAILABLE- The Randolph YMCA welcomes deserving individuals & Families who are unable to pay the full cost of programs or membership. Financial assistance is provided by the Annual Campaign. Please print out an application online or at the front desk.

No credits will be issued for absences from the “Play & Learn” Program. Program fees are paid monthly at a flat rate as indicated on your Billing Agreement.
